Resolution No. 680

Adopt Resolution No. 680, fixing the Real Estate Tax Rate for general revenue purposes at a sum of 2.95 mills on each dollar of market valuation for 2023. This is the same rate as 2019, 2020, 2021, and 2022. The Borough is listed as the 17th lowest municipality (and includes waste disposal in the tax rates) out of 130 for the 2022 Municipal Tax Millages on the Allegheny County Treasurer website.
