Environmental Disturbance Application 23-09

Re-Imagined Real Eastate, LLC – Amy M. Kelleher, President Submitted by Hampton Technical Associaites, LLC 280 Glen Laurel Lane New Single Family Dwelling

The EAC recommends approval of Environmental Disturbance Application 23-09, as submitted, contingent upon the 1:1 replacement of the trees being removed with deciduous hardwoods and with the other required conditions outlined in the LSSE letter dated April 6, 2023.

Environmental Disturbance Application 23-10

Matthew & Anne A. Johnson Submitted by Hampton Technical Associates, LLC 100 Hillcrest Road New Single Family Dwelling

The EAC recommends approval of Environmental Disturbance Application 23-10, as submitted, contingent upon the alteration of the proper replanting plan with 13 canopy hardwoods and five ornamentals, including the granting of the two soil stability waivers from the very steep slopes with high-risk up to 6.3% disturbance, and very steep slopes with low risk up to 22.89% disturbance. The recommendation also includes the remaining requirements outlined in the LSSE letter dated April 10, 2023.

# **CONTRACT AWARD**

### Contract No. 23-R01, 2023 Roadway Improvement Program

This Contract was bid to include Fox Chapel Borough, O'Hara Township, and the Fox Chapel Water Authority. Awarding the Contract to the low bidder, Shields Asphalt Paving, Inc., is recommended at the base bid of \$983,152.50. Alternate Nos. F-2, F-3, F-4, F-5, and F-17 of Contract No. 23-R01 - 2023 Roadway Improvement Program bring the total to \$1,428,161.50. This amount includes \$51,000 for the Utility Pavement Repairs will be completely reimbursed to the Borough upon completion by respective utility companies, and \$7,178.75 for bituminous restoration at the Public Works Operation Center will be paid out of bond issue funds. The total from the Road Paving Budget will be \$1,116,286.50. The 2023 Road Paving Contractor Budget is \$1,100,000.

Bids were received on Municibid for the 30' X 60' steel storage building sale. It is recommended to award the sale of the building to the second-highest bidder, Daniel Green, at \$1,400.

Bids were received on Municibid for the 2009 ODB LCT600 Belt-Driven Leaf Collector sale. It is recommended to award the sale of the machine to the high-bidder, Craig Matis, at \$7,500.00.

### Municibid – 2005 8' X 16' Custom-Fab Equipment Trailer

Bids were received on Municibid for the 2005 8' X 16' Custom-Fab Equipment Trailer sale. Awarding the trailer sale to the high-bidder, Matthew Lutz is recommended at \$2,950.00.

<u>Correspondence with Brent Wasko, Public Information Officer for Allegheny County Department of Public</u> <u>Works, Regarding Fox Chapel Road Intersections</u>

Mr. Wasko updated Manager Koehler on PennDOT's reviews of intersections along Fox Chapel Road.

- **Fox Chapel Road at Powers Run Road**, The County, and PennDOT stated an additional stop sign is still not warranted and had a few recommendations. The Police Department will perform traffic counts and provide this information to the Borough Engineer to determine the next steps.
- **Fox Chapel Road at Foxhurst Drive,** After extensive evaluation, the County determined the intersection was constructed appropriately according to the plan and that the as-built sight distances met or exceeded the proposed values. The County does not believe additional signage, including new stop signs or pavement markings, is needed at this intersection.
- **Fox Chapel Road at Chapel Ridge Road/West Chapel Ridge Road** After extensive evaluation, the County has determined that a stop sign is warranted at the intersection of Fox Chapel Road at West Chapel Ridge Road/Chapel Ridge Road. Therefore, Council should authorize the advertisement of the proposed Ordinance 724 developed by Shawn Peterson and Bruce Bowden.
