# Mayor's Memo

The Hardie property acquisition has become a reality for the Borough and will add a vital missing link to our parks and trails. I would like to thank the Hardie family, and many others, for helping to make it possible. We still have work ahead! Our goal is to raise over one million dollars to pay for the acquisition and work needed to open the park for public use. We have raised approximately \$250,000 from generous donors, including over \$50,000 from Borough Council, Mayor and staff members. Thank you to all who have donated!

This property fits in perfectly to our existing group of parks and has been of interest to the Borough for over 20 years when discussions first began with the Hardie family. Residents have made expansion of our parkland available in the past through generous donations of land and funds to buy land. There will be a series of public meetings later this fall to get resident input in planning for the use of this parcel. The Borough is in the process of engaging a Park Planner to help with the process. Please watch for dates for these discussions.

# Update - Borough Building Site Improvement Project

The first phase of the public works facilities upgrade is underway. Council budgeted \$1.1M this year for the site preparation. Work continues regarding compliance with environmental mandates such as storm water control and stream setback which are required. As a reminder, this work will disrupt parking at the Borough office during reconstruction of the front parking area as well as the entrance into the driveway. It is anticipated that completion of the first phase will be in December, and the Borough rubbish bins will remain closed until then.

# Holiday Garbage Collection Schedule and Driveway Reminder

Garbage will not be collected on Thanksgiving Day, Christmas Day and New Year's Day thus delaying garbage collection one day following the holiday for the remainder of the week.

With winter weather approaching, Vogel Disposal would also like to remind residents to keep driveways clear of snow and ice. If the driveway is not accessible due to dangerous/slippery conditions, garbage will not be collected. If bad weather is predicted on collection day, it is recommended that the garbage cans be placed at the curb to ensure pickup. Your cooperation is appreciated. Call Vogel directly for a missed garbage collection or any collection problems toll free at 1-855/494-3345 and press 1 for Customer Service. Please do not call the Borough office – you will be instructed to call Vogel directly.



# **Fall Leaf Collection**

Leaf composting and placing leaves in wooded areas of your property is highly recommended and remind landscapers to do the same. Your help in removing leaves from the collection program is needed and appreciated.

Collection will begin on October 15th (brush and decorative grasses are not included). Once a complete pass has been made through the Borough, the crews will start over on the first street and continue again throughout the Borough. All leaves should be deposited on the lawn BEHIND the curb or road edge, not on the pavement or in the gutter. **LEAVES PLACED ON THE ROADWAY WILL NOT BE COLLECTED**. This is important because leaves placed in the street can become soggy from street runoff which makes them extremely difficult to vacuum and increases the time required to remove the leaves. It also creates a safety problem by reducing the cart way available to motorists and pedestrians. (Ordinance No. 535 prescribes a penalty of \$1,000 for anyone placing such materials on a road.) Due to equipment limitations, leaves placed further than 6 feet from the curb cannot be collected. Borough personnel will not rake leaves down to the curb that are located outside the 6-foot limit. The final collection will start December 3. *Any leaves placed after December 3 will not be picked up.* Please make certain to notify landscapers of the cutoff date and the need to keep the leaves off the street. (Please email Dempsey Bruce at dbruce@fox-chapel.pa.us if you would like a load or more of leaves delivered to your home.)

Please be aware that should the Borough experience the steady falling of leaves this fall, it could take as long as three weeks between collections. (Sometimes it takes Borough personnel an entire day to collect one street.) The Public Works Department keeps a daily log of streets collected so the Borough is aware of the number of collections made on a particular street. Your patience during leaf collection is greatly appreciated.



## **Brush Collection**

A reminder to residents that there is no brush collection in the fall. Brush collection occurs in March and April and information is placed in the Winter Newsletter.



# **Christmas Tree Recycling**

The Borough will provide a *curbside* pickup of Christmas trees. All trees must be brought to the curb by Monday, January 13th, with the cut end facing the street. All trimmings must be removed. Barring inclement weather, the collection usually takes only three days to complete. If you miss the curbside collection, Christmas trees can be brought to the bin area behind the Borough Building during normal bin hours (10 AM to 4 PM, Saturday & Sunday). Vogel Disposal does not collect Christmas trees.



## **False Fire Alarms**

Every year the Fox Chapel Volunteer Fire Department responds to numerous false alarms and a typical response involves people leaving their jobs, dinner tables, family functions, holiday celebrations and sometimes getting up in the middle of the night. It also involves responding with almost \$1,000,000 worth of sophisticated equipment. Every response to a false alarm means needless wear and tear on that equipment and increases the chances for an accident involving volunteers and fellow residents.

Our firefighters are local property owners and residents of the surrounding communities just like you. As volunteers, they care enough about the lives and property of our neighbors to willingly invest in many volunteer hours of training, education and preparation in order to properly respond to true emergency situations.


The Borough is not trying to discourage the use of alarm systems. Early fire detection equipment can save both lives and property. We just want residents to be familiar with their alarm system, maintain it properly and follow the standard operating procedures as outlined by the alarm company. Please take the time to review the alarm system and call the alarm company to have the system checked and repaired if necessary. All property owners should instruct contractors to cover all interior smoke detectors to avoid false alarms. Most false alarms are caused by contractors not covering the smoke detectors. We feel that by following these guidelines, we can significantly reduce the amount of needless false alarms and risk to our men and equipment.

# Fire Safety Tips from the Fire Department

- Remember to check smoke detectors and change the batteries when the clocks are changed in the spring and fall.
- Service, clean and check fire alarm.
- Confirm ALL family members know what to do in the event of a fire - know the appropriate escape routes (should have more than one), practice them and have a pre-set meeting place.
- Always sleep with bedroom doors closed. This will keep deadly heat and smoke away allowing additional time to escape.
- If fire threatens the home, exit the home first and then call 911.
- Time is critical. Do not waste time getting dressed or searching for valuables. Just get out!



# **Snow Removal/Street Parking**

Residents are reminded that street parking is prohibited during periods of snowfall, ice accumulation and inclement weather. Vehicles parked on public roads during the deposit or accumulation of snow or ice present a traffic hazard and impair the Borough's ability to effectively remove all snow or ice from the roads in a safe and expedient manner. The Police Department will tow any vehicle parked along any public roadway during inclement weather. In a related matter, it is also unlawful for residents to shovel any snow from any driveway/sidewalk/private road onto any public road. Your cooperation is greatly appreciated.



# **Ice Skating Rink**

We are asking those who use the ice-skating rink at McCahill Park during the winter months to **please observe the "Closed" sign when posted.** The main reason for closure is the ice surface is not completely frozen. Borough personnel post the sign as well as place yellow tape across the entrance and yet the tape is removed and skating occurs causing damage to the rink's liner. This has happened on several occasions since the rink has been installed and ruins skating for all. We are asking residents to help the Borough patrol the rink and notify police when usage occurs when closed. The rink has become a popular attraction during winter months, and it is the Borough's desire to continue the tradition for years to come.

# Deer Management

During the 2018-2019 hunting season, a total of 120 deer were removed: 15 by vehicles, 22 by archers and 83 by the police sharpshooters. This compares with 98 deer removed the year before.

Archery season begins Saturday, September 21, for white-tailed deer in Allegheny County. As in previous years, the Borough assists residents who want to have a hunter on their property by providing a pre-qualified archer as long as there is an adequate safety zone on the property. While the law allows you to give permission to any licensed archer to hunt on your property, we strongly encourage you to obtain a pre-qualified archer through the Borough's pool of archers are much more proficient at removing deer than non-pool archers.

The second part of the Borough's deer management program involves the use of police officers to remove deer at night at selected sites throughout the Borough. All meat obtained in this manner is donated to Hunters Sharing the Harvest. This aspect of the program extends from February 1st to September 30th but generally all such activity ceases from April through August.
