HOUSEHOLD HAZARDOUS WASTE (HHW) AND E-WASTE COLLECTION

Household Hazardous Waste and Electronic Waste Collection are by appointment only, with the following dates for collection in 2023:

- Monday, March 27th, scheduling cut-off will be Monday, March 13, 2023
- Monday, September 11th, scheduling cut-off will be Monday, August 28th, 2023

Contact Vogel Disposal Service, Inc.'s Customer Service Department, 855/494-3345, to schedule at least ten business days before the collection date. Please be prepared with detailed information about the products you request be picked up during the call. You will need the following information for Hazardous Household Waste: the brand name, container size, quantity remaining in the container, and possible information from the label. ALLEGHENY COUNTY SANITARY AUTHORITY RATE INCREASE

The Allegheny County Sanitary Authority's (ALCOSAN) Board of Directors approved a rate structure on October 28, 2021. The rate structure enables ratepayers to plan for future expenses strategically. The increases, effective for water used beginning January 1 of each year, will be 7% for 2023 and 7% for 2024, 2025, and 2026. The increases will be used to pay for infrastructure changes and to implement the authority's Clean Water Plan. The plan is intended to keep raw sewage from spilling into local waterways during heavy rains.

Effective January 1, 2023, the wastewater treatment charge will increase by 68 cents from \$9.73 to \$10.41 for every thousand gallons used, and the customer service charge will increase by \$1.43 from \$20.45 to \$21.88 per bill issued. The rates for effluent surcharges, commercial disposals, and auxiliary meters will remain the same.

Residents of the Borough of Fox Chapel will see a 7% increase on their Fox Chapel Authority bill in the new year.

RESIDENTIAL RECYCLING INFORMATION

Did you know that nine-tenths of all solid waste in the United States does not get recycled? Landfills are among the most significant contributors to soil pollution. Roughly eighty percent of the items buried in landfills could be recycled. Let's take a closer look at what can be recycled here in Fox Chapel.

INCLUDE THESE:

- Cardboard: flattened cardboard boxes, dry food boxes, clean pizza boxes
- Paper: newspaper, junk mail, office paper, and magazines
- Plastic: water and soda bottles, milk and water jugs, plastics #1, #2, and #5
- Metal: empty aluminum cans, steel and bi-metal cans, clean aluminum foil

A reminder to residents that cardboard, metal recycling, and glass recycling containers located at the Borough Building's rubbish bins can be accessed during regular bin hours Saturday and Sunday, 10 AM to 4 PM. Please note that electronics (e-waste) cannot be brought to the rubbish bins. State law requires all electronics to be recycled.

ANIMAL CONTROL

The Borough often receives calls to trap animals or remove dead deer from private property. The Borough does not provide animal control services, and the Police Department does not remove dead deer from personal property. Residents should contact an animal control service to trap or remove a dead animal from their property.

FROM THE DESK OF CHIEF OF POLICE

The Fox Chapel Police Department hopes your holidays were filled with joy and memories built with family and friends.

A few alarming trends have been stealing joy from all of us. Identity theft and vehicle break-ins. If you or a loved one receives an email, text, or phone call requesting you to change your passwords or provide your personal information, politely decline and call the entity directly to see if they need to speak to you. Criminals have ways of spoofing phone numbers to appear legitimate, but the number calling you is generally from out of the country. Everyone should check their credit histories periodically and especially if they have fallen victim to one of the numerous identity theft scams.

Vehicle break-ins have been reported in the Borough. One type of break-in happens in the very early hours of the morning. Generally, it involves unlocked vehicles ravaged by thieves looking for change, sunglasses, electronics, guns, wallets, purses, and vehicle keys. If you leave your keys inside your vehicle, there is a good chance your car will be stolen. If you leave a remote garage door opener inside your unlocked vehicle, you provide the criminal access to your home. Removing valuables and locking the doors of unattended vehicles is the best deterrent to these types of thefts.

The second type of vehicle break-ins happens at fitness clubs, churches, and park parking lots during business hours. These elaborate thieves are looking for purses or wallets and will use a glass punch to break your vehicle's glass to gain entry. Wallets, handbags, and cash will be stolen, and credit cards will be immediately used to buy gift cards and expensive items at local establishments. The credit cards will be used until they are denied at checkout. These thieves will conduct their criminal activity in an area and immediately leave to continue their vehicle break-ins in a different area miles away. Residents can be proactive by not providing a target of opportunity for thieves. Do not leave your purses, wallets, or valuables in your unattended vehicles. And **ALWAYS** call 911 to report all suspicious activity. Have a safe, healthy, and prosperous 2023.

COUNTY AND STATE ROAD REPAIRS

The Borough receives pothole complaints and other calls for roads that the Borough does not maintain. The Borough cannot repair a State or County road. Potholes on County roads should be reported to Hotline 412/350-2513 and include: Fox Chapel Road (from Freeport Road in O'Hara Township) to Guys Run Road; Delafield Road (from Fox Chapel Road to Borough/Aspinwall line), and Dorseyville Road.

Potholes on State roads should be reported to Hotline 412/781-3260 and include: Fox Chapel Road (Guys Run Road to Dorseyville Road) and Powers Run Road. As a service to our residents, and as allowed by the County and State, the Borough does provide winter maintenance (salt/plow service) on County and State roads and is reimbursed for salt.

WAGE TAX PAYMENTS

The Borough encourages residents to verify with Keystone Collections Group (724/978-0300) that wage tax payments are current to avoid interest and penalties. Often when wage tax payments are verified due to a home sale or refinancing, a large sum of money is due plus penalty and interest, which could delay the closing. Renters of property in the Borough must also pay wage taxes and are required by ordinance to register with the Borough.

TAX COLLECTORS

All self-employed persons whose primary business is Fox Chapel Borough must pay a \$52 Local Services Tax for emergency services and road maintenance. Each employer in the Borough, including residents with home occupations, is charged with the duty of deducting the tax from each of their employees and remitting payment to Keystone Collections Group, 546 Wendell Road, Irwin, PA 15642 (724/978-0300), within thirty days after the end of each calendar quarter. Keystone also collects earned income tax (EIT) for the Borough. All tax forms are available online at www. keystonecollects.com. (Reminder that the Borough's PSD Code is 710403.)

Jordan Tax Service collects Real Estate taxes for the Borough. Jordan is located at 102 Rahway Road, McMurray, PA 15317, 412/345-7962, www.jordantax.com. Questions regarding tax payments, refunds, or tax receipts should be directed to Jordan Tax Service. If your mortgage has been paid off, please contact Jordan with the new mailing address to send tax statements to avoid delinquency.

SNOW REMOVAL/STREET PARKING

Residents are reminded that street parking is prohibited during snowfall, ice accumulation, and inclement weather. Vehicles parked on public roads during the deposit or accumulation of snow or ice present a traffic hazard and impair the Borough's ability to effectively remove all snow or ice from the roads safely and sensibly. The Police Department will tow any vehicle parked along any public roadway during inclement weather. In a related matter, it is also unlawful for residents to shovel any snow from any driveway/sidewalk/private road onto any public road. Your cooperation is much appreciated.

WINTER SAFETY TIPS

As the air turns colder, keeping a few safety tips in mind is important. With proper precautions and safety awareness, your family can enjoy the crisp weather while avoiding some of the dangers of the season.

When the weather turns cold, most people spend more time indoors using fireplaces, furnaces, and heaters to keep warm. Nothing is quite as cozy as a fire, but it presents some safety hazards. Keep these tips in mind:

- Use Fireplaces Safely Keep the fire in its proper place by using a fireplace screen to keep sparks from flying out of the fireplace. Never leave a burning fire unattended, and ensure a fire in a fireplace is completely out before going to bed.
- Service Your Furnace Be sure to call a heating and cooling company to service your furnace. A specialist should inspect the furnace to ensure everything is in working order and that there are no leaks.
- Use Caution with Space Heaters A space heater can be an effective way to warm up a cold room, but you must read the
 instructions on the unit before its use. If the space heater requires venting, ensure it is vented outdoors. Never use a stove or
 oven to heat a home; only use space heaters approved for this purpose. Always allow at least three feet of empty area
 around space heaters.
- Exercise Candle Caution Candles are a great way to give a room a warm glow but can also cause fires. According to the
 National Candle Association, almost 10,000 home fires start with improper candle use. Never burn candles if you go out or
 sleep, and keep candles away from pets and kids.

2023 BUDGET

We are pleased to report there will be no tax increase for residents again this year. The millage rate has remained at 2.95 mills since 2019. Of the 130 municipalities in Allegheny County, Fox Chapel is proud to be the 17th lowest compared to other municipal millage rates. Your taxes include garage door garbage service unique to Fox Chapel.

2023 General Fund operating revenue and expenditures are both budgeted at \$9M; thus, the 2023 budget is break-even with a minor surplus of \$5,800.

Our revenue sources are limited compared to other municipalities because we have no commercial business district. Most of Fox Chapel is developed; therefore, there is limited income growth from additional residents. As a result, our primary sources of revenue are Real Estate Tax and Earned Income Tax. Of the \$9M budgeted revenue, \$7.3M is from these two income sources. Real Estate Tax is expected to bring in \$3.6M and Earned Income Tax.

Our largest expenditure is for the Contracted Road Paving Program at \$1.1 M. The Borough bids its road paving jointly with O'Hara Township enabling both communities to receive lower bids due to the economies of scale. The Borough's Public Works Department performs the necessary storm sewer work before paving to lengthen the roads' lifespan and control stormwater.

Please note this may change due to the actual bid amount received and other variables.

Fox Chapel Borough supports the Cooper-Siegel Community Library, Foxwall EMS, and the Volunteer Fire Department. \$350,000 is given annually to the Cooper-Siegel Community Library, and \$56,100 will be given to Foxwall EMS, including a \$10,000 donation toward a new ambulance. The Borough helps support the Fox Chapel Volunteer Fire Department. Your donations to the annual Volunteer Fire Department Fund Drive are greatly appreciated, and 100% goes to purchasing a new rescue truck scheduled for 2024 that costs approximately one million dollars.

In 2022, Capital Equipment purchases included two Chevy Tahoe Police vehicles and three Public Works trucks. In addition, the Borough purchased body-worn and in-car cameras for the Police Department. In 2023, Capital Equipment purchases include \$235,300 for the Public Works Department leaf boxes and a 4-wheel drive truck and \$23,900 for the Police Department rifles and accessories.

McCahill Park upgrades will continue in 2023; Phase Two includes new backstops, a walking trail, innovative stormwater controls, and a seasonal multi-use pad that will allow pickleball courts, basketball, and an ice rink.

In 2019, the Borough issued \$5.4M in general obligation bonds to be repaid over 25 years at an annual cost of \$300,000. Our excellent AA+ credit rating from Standard and Poor's helped reduce the financing costs to Borough taxpayers, and the Borough has no other outstanding debt. The Bond was issued to cover the construction of an energy-efficient Public Works garage which is now complete. The next phase will be to repurpose two existing garages built in 1959 and 1985 and construct ADA-compliant restrooms in the Borough Building.

Borough sanitary sewer rates will remain the same in 2023 due to the receipt of over \$961,700 since 2019 from ALCOSAN's Green Revitalization of Our Waterways (GROW) grant. This grant has been received as the Borough demonstrated a measurable reduction in groundwater infiltration into our sanitary sewer lines.

WHERE DOES YOUR PROPERTY TAX DOLLAR GO?

- Many people do not realize that there are three different property taxes: School District, County, and Borough
- The Borough has no control over the County and School District taxes
- The current 2023 rates for each taxing body are as follows:



For each dollar in property taxes you pay, the School District gets seventy-three cents, the County receives seventeen cents, and the Borough gets ten cents. With the 10-cent Borough share, the Borough provides Police and Fire protection, road paving, snow/ice removal, leaf and brush removal, trash collection, code enforcement, parks, communications, library, and other services. These services are highly visible and vital to your everyday well-being.

VOLUNTEERS HELP MAKE PARK IMPROVEMENTS

On October 14, 2022, nine volunteers and Borough Public Works staff met at Scott Park to plant various native trees. The trees included swamp white oak, river birch, redbud, serviceberry, and bottlebrush buckeye. Smaller trees and shrubs were purchased from Tree Pittsburgh, including pawpaw,

spicebush, redbud, and several oak trees. Tree Pittsburgh grows all its trees from seeds allowing for more diverse DNA amongst each species. Additionally, small buttonbush seedlings were planted alongside the streams with the hopes that as they mature, their roots will help reduce soil erosion on the side of the streams.

Approximately three dump truckloads of invasive plants were removed from the park earlier in the week to prepare for the planting. This included privet, barberry, multi-flora rose, and a patch of Japanese knotweed. All residents are encouraged to remove invasive plants they find on their property to help control their growth.

Fifteen larger diameter trees were then planted alongside the road surrounding the park with the hopes to continue producing more trees in the future.

After witnessing the transformation of Scott Park, the Fox Chapel Conservancy generously gifted monies to be used towards the purchase of trees in Riding Meadow Park.

At the entrance to Riding Meadow Park, redbud and serviceberry trees were planted to provide a warm welcome to visitors. Throughout the park, larger-diameter native trees were placed in areas cleared of privet. River birch and red twig dogwood can now be seen alongside the creek.

Following the large planting, Melinda Guinn, a Fox Chapel Borough resident, and eleven other volunteers, including some Fox Chapel Area High School Environmental Club members, helped plant fifty buttonbush seedlings along the challenging, rocky creek bank in Riding Meadow Park on October 24, 2022. They covered almost one hundred feet of streambank with the seedlings. Additional seedlings were planted further down the creek bed in areas where the hillsides were eroding.



Ms. Guinn also helped plant twenty-five buttonbush seedlings along the Trillium Trail with her family. The Borough of Fox Chapel thanks the many volunteers who helped make these improvements that will be around for generations.

The Borough would also like to thank the Bowden Family, Wesley Posvar, as well as the following individuals:

DRIVEWAY IMPROVEMENT PERMIT PROTECTS MOTORISTS FROM WATER RUNOFF AND ICE ON BOROUGH ROADS

Since 1944, the Borough of Fox Chapel has required driveway permits for anyone installing a driveway in the Borough's right-of-way. The Borough's right-of-way is fifty (50) feet in most cases. This means about twelve (12) feet from the edge of the paving in a resident's front yard.

The right-of-way is used for underground utilities such as sewer, gas, water, cable, and stormwater piping. Anyone working within the Borough's right-of-way must call PA One Call at 811 before digging or excavating in the right-of-way or on the property, and digging without a One Call risks damaging one of the buried utilities and can disrupt you or your neighbor's service.

The Borough regulates driveways because water from the gutter line or the driveway may be directed onto the asphalt road's surface and freeze. This can create a hazardous condition for motorists or walkers. The Borough's permit process protects residents from accidents and reduces residents' liability by not allowing the driveway to create a dangerous situation.

While planning property improvement projects for the spring, please be aware that driveway modifications require a Driveway Improvement Permit from the Borough before starting any work such as repaving, changing the material, grade, or drainage pattern. The Driveway Permit Application and information are available on the


Borough's website. The permit fee is \$100. If you have any questions, please contact Chuck Smith at 412/850-5030.

Vogel Disposal is closed in observance of the following holidays each year: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. If your scheduled collection day falls **ON or AFTER a weekday holiday**, your collection will be 1 DAY LATER that week.

Vogel Disposal reminds residents that all garbage must be in a tied bag before placing it in the garbage container.

- Bags need to be 33 gallons or less and cannot weigh more than 45 pounds
- NO CONTRACTOR BAGS
- Do not place waste in individual grocery store plastic bags.
- Loose garbage will not be collected. (Please note that it is not the collector's responsibility to clean debris strewn in the driveway resulting from an animal.)
- Cardboard needs to be broken down into pieces no larger than four feet. Place cardboard lose in the recycling bin.

Vogel Disposal also reminds residents to keep driveways clear of snow and ice. Garbage will not be collected if the driveway is not accessible due to dangerous/slippery conditions. If bad weather is predicted on collection day, it is recommended that the garbage cans be placed at the curb to ensure pickup.

Large items such as lamps, large toys, vacuum cleaners, small household appliances, and aluminum/resin lawn furniture 45 pounds or less can be picked up by Vogel Disposal on your scheduled garbage day, eliminating the need to bring it to the Borough rubbish bins.
